Meeting Minutes

April 19, 2017

Introductions & Minutes: The meeting opened with introductions led by Nancy Norby. The minutes from the March meeting were approved on a motion by Bing Wong, seconded by Jim Smith, and passed with an oral vote.

Treasurer's Report: The financial report was presented by treasurer Bing Wong. The total balance of checking plus savings on April 18, 2017 was \$6,773.62. Nancy Norby requested reimbursement for the annual \$110.00 for cookies provided at MTNA meetings which was approved at last month's meeting.

Neighborhood Crime Issues: Because a Portland police officer did not attend the meeting, this agenda item was tabled for the month. Online crime reporting is on the City's website here: <https://www.portlandoregon.gov/police/cor/>.

Announcements: Paul Leistner said he hasn't yet but will soon contact the (Oregon) State Historic Preservation Office and (Portland) Historic Landmarks Commission to inquire about a drive through the Mt. Tabor neighborhood and assessment whether any of the neighborhood might qualify as a historic district.

Nancy Norby said the Mt. Tabor Park Master Plan includes removal of the compost collection areas in the park and she will contact the Portland Parks Bureau to make a request to get that process started.

The site of the old Washington High School property located between SE Stark, Morrison and 12th and 13th Streets has a 1.3-acre parcel that is owned by Portland Public Schools. The central eastside neighborhoods are parks-poor and lack a community center, so this parcel is a rare opportunity for it. Sam Noble made a motion to ask the City of Portland to exercise their

right to purchase this parcel from Portland Public Schools before their rights of first refusal expire in May. Bing Wong seconded the motion, and it passed by an oral vote in favor.

60s Neighborhood Greenway/Bikeway: As part of the Growing Transit Communities Project outreach by Portland Bureau of Transportation (PBOT) and the North Tabor Neighborhood Association, SE Uplift's vice chair Terry Dublinski-Milton provided a slide show and information about the 60s Neighborhood Greenway/Bikeway which is the Project's next regional priority. Currently, there is a gap in the north-south network that spans the SE Uplift coalition area between the 50s and I205. The 60s Greenway/Bikeway will serve six SE Uplift neighborhoods by building pedestrian crossings at 12 high-crash and neighborhood corridors and creating a MAX-to-Division transit connection. Leveraging a path around the east side of Mt. Tabor Park will provide a north-south bike and pedestrian corridor which is less expensive, safer, requires less parking removal, and will displace less traffic than other options on the west side of the park. Advocacy requests for this concept came from the Brentwood-Darlington, Foster-Powell and South Tabor neighborhood associations with a unanimous SE Uplift Board vote of endorsement. Mt. Tabor Neighborhood Association board member Brian Mitchell made a motion for MTNA to support the concept of bringing a north-south bike and pedestrian route through our neighborhood, Sam Noble seconded the motion, and it passed with an oral vote in favor of the motion.

Thorburn Safety Project update: Debra Monzon gave an update on the results of the traffic speed tests conducted on Thorburn. Since the speed limit was lowered by 5 mph, speeds on average were lower by only 3 mph. Ten speed bumps have been approved for installation this season.

Mt. Tabor Park stair handrail project update: Jaime English, Portland Parks and Recreation project manager, gave an update on stair handrail projects planned in Mt. Tabor Park. The project considerations included ADA compliance, long-term maintenance and the historic park setting aesthetics. The longest series of new railings will be along the "grand staircase" on the northeast side of the park leading to the top where there are no railings currently. International Student Home Stays: Tanja Kontturi, from ANDEO International Homestays, provided handouts and a brief overview of their Portland-based nonprofit educational homestay programs (ages 14 years through college). CPOT is the City of Portland's cannabis policy advisory group made up of community members, cannabis industry members, and health officials (among other stakeholders). CPOT facilitates discussion about cannabis policy to ensure that Portland's cannabis regulations are fair for businesses, maintain the safety and livability of our neighborhoods, and reflect Portland's values. The City of Portland Budget Committee will hold a public hearing about the annual budget for the Mayor and City Council to receive testimony from Portland residents regarding the citywide budget for the upcoming fiscal year. Testimony tickets will be available an hour and a half prior to start time. They will be drawn at random throughout the course of the event. Each speaker will have two minutes to address the council. The hearing will take place on Thursday, May 11, from 6:00pm - 8:30pm at City Hall, Council Chambers, 1221 SW 4th Ave, Portland.

SE Uplift News: Vibe of Portland is the temporary tenant at the Tabor Commons/Cafe au Play space. Vibe connects local teaching artists to students without the means to get music and visual arts classes outside of their school day. Vibe has partnered with PTAs at Atkinson and Bridger Elementary schools among others in the Mt. Tabor area.

At their most recent monthly meeting, SE Uplift renewed all the fiscal sponsorships for MTNA projects, including the Gateway, Reservoir, Thorburn Safety, and a general MTNA fund.

MTNA is considering a fall neighborhood cleanup. Further research is needed about finding ways to keep prohibited materials (like asbestos) out of the collection bins to avoid fines. It was reported that the Buckman neighborhood cleanup simply has a no-construction-materials policy. MTNA will observe how the cleanups go for the Foster-Powell neighborhood association on May 6 and the Richmond neighborhood association on May 27.

Friends of Mt Tabor Park Update: Restoration of the restrooms at the top of the park is under way. Once the work is completed and the restrooms are functional again, plans are to lock the bathrooms at night.

The meeting adjourned at 8:30pm.

The next meeting of the Mt. Tabor Neighborhood Association will be Wednesday, May 17, at 7:00pm at Mt Tabor Presbyterian Church at SE 54th and Belmont, with social time and homemade cookies starting 6:50 PM.
